

**“Ask Troy Murray 2016-17” Sweepstakes
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1) Eligibility: The “Ask Troy Murray 2016-17” Sweepstakes (the “Sweepstakes”) is open to legal U.S. residents of Illinois, Indiana, Michigan or Wisconsin who are 18 years old and older as of September 16, 2016. Employees (and their immediate household or family members) of WGN Radio (“Sponsor”) and its parent companies, affiliates, subsidiaries, advertising agencies, prize providers, promotion and delivery contractors and/or public relations companies associated with this Sweepstakes, are not eligible to participate. Employees of participating clients and their advertising agencies or of other media companies including all radio or television stations and members of the immediate family of any such persons are not eligible to participate and win. A potential winner may be requested to provide proof that all eligibility requirements are met. Void where prohibited and outside the Sweepstakes area above.

2) How to Enter: Sweepstakes starts at 8:00 am CT on Friday, September 16, 2016 and ends at 11:59 pm CT on the night before the final game of the Chicago Blackhawks 2016-17 season (includes all pre-season, regular season and any post-season games played (the “Sweepstakes Entry Period”).

Enter during the Sweepstakes Entry Period by submitting an email with a question for Troy Murray (the “Question”) at asktroy@wgnradio.com. Entrants must provide their name, birthdate, address, telephone number(s), and email address. Entrants must use their own name and current residential address. Questions are limited to one person per game and a winner can win only one first prize. Entrants may not ask the same question twice.

3) Conditions of Entry: No mechanically reproduced entries will be accepted. Entries containing technical or electronic reproductions or attached files are not eligible and will be rejected. If any dispute arises as to identity of any entrant, the entrant will be considered the individual to whom the entry’s email address is assigned, as shown on the email service provider’s records. Only entries to the designated email address will be eligible. Sponsor reserves the right in its sole discretion to disqualify any entry at any time which in Sponsor’s opinion does not comply with these Official Rules. Sponsor is not responsible for lost, incomplete, damaged, illegible, late, or misdirected entries, or for errors in mechanical transmission, technical difficulties or inability to transmit Internet entries. Participation in the Sweepstakes is subject to these Official Rules. Received entries become the property of Sponsor and will not be returned or acknowledged. Your information will be treated in accordance with Sponsor’s Privacy Policy, which is located at privacy.tribune.com and which may be amended from time to time. By entering, entrants agree to be bound by and comply with these Official Rules.

4) Question Submission Requirements:

- Must be the original creation of the entrant;
- Must be in English;
- Must be no more than 25 words;
- Must not contain material that is inappropriate, indecent, lewd, pornographic, obscene, hateful, tortious, defamatory, slanderous or libelous; and
- Must not contain material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, religion, nationality, disability, sexual orientation or age.

By entering, each entrant represents and warrants that the submitted Question is in compliance with all of the foregoing requirements. By entering, each entrant understands and agrees that the Question may be read on air on WGN Radio and posted on the WGN Radio website, and the Question must be appropriate for broadcast on a general-interest radio station and display on the station website. By entering, each entrant grants to the Sponsor and its licensees a world-wide, perpetual, non-revocable, royalty-free, sub-

licensable license to publish his/her Question as well as derivative works based thereon on WGN Radio, on Sponsor's websites, in Sponsor's apps, on social media, and through any and all other media, now known or hereafter devised, in any manner related to the Sweepstakes, without prior notice, approval or compensation. Entrant represents and warrants that Sponsor's use of the Questions as provided for herein will not violate the rights of any third party. Entrants otherwise will retain all rights to their respective Questions. Each entrant agrees to indemnify, defend and hold Sponsor harmless against any and all liabilities, losses, damages, claims, debts, investigations, fines, penalties, costs, expenses and settlements (including attorneys' fees and costs of litigation, settlement, judgment, interest and penalties) arising out of or related to a breach of any of the foregoing representations and warranties. Sponsor reserves the right to reject any entry at any time that, in its sole and absolute discretion, is determined not to meet the above specifications.

5) Winner Selection and Notification: On or before the date of every Chicago Blackhawks pre-season and regular-season game (September 28 and 30; October 1, 2, 4, 8, 12, 14, 15, 18, 21, 22, 24, 28 and 30; November 1, 3, 5, 6, 9, 11, 13, 15, 18, 19, 21, 23, 25, 26 and 29; December 1, 3, 4, 6, 9, 11, 13, 15, 17, 18, 20, 23, 27, 29 and 30; January 2, 5, 6, 8, 10, 13, 15, 17, 20, 22, 24, 26 and 31; February 2, 4, 8, 10, 11, 18, 19, 21, 23 and 26; March 1, 3, 4, 9, 10, 12, 14, 16, 18, 19, 21, 23, 25, 27, 29 and 31 and April 2, 4, 6 and 8) and every Blackhawks post-season game (if any), Sponsor will select a potential first prize winner in a random drawing from among all eligible entries received by 11:59 p.m. CT the day before each game, subject to verification and compliance with these Official Rules. Non-winning entries will carry over from one game to the next. Please note, the quality of your Question will not play a role in the determination of the winner. There will be a minimum total of 88 first prize winners, and, after the close of the Sweepstakes Entry Period, Sponsor will do a random drawing from among all eligible entries to determine the Grand Prize winner. Sponsor will attempt to notify each winner by email or telephone on or shortly after each drawing. Winner will be disqualified and an alternate winner may be selected by random drawing from among all remaining eligible entries for that drawing (time permitting and at the sole discretion of Sponsor) if: (a) winner cannot be contacted/does not respond within 48 hours of Sponsor's first notification attempt; (b) winner does not fulfill the eligibility requirements; (c) winner does not adhere to the Official Rules; (d) winner does not sign and return any required documents and provide required identification by deadline established by Sponsor; and/or (e) prize notification is returned as undeliverable, refused, or declined. Odds of winning depend on the number of eligible entries received for each drawing.

6) Prize and Prize Restrictions: Minimum of 88 First Prizes: \$25 Pequod's Pizza gift certificate (valid at Chicago or Morton Grove locations) to the winner whose question is read on the air and answered by Troy Murray.

One Grand Prize: The Grand Prize winner will receive two tickets to a 2017-18 Chicago Blackhawks regular-season game at the United Center with the date and seat location to be determined by WGN Radio. Approximate retail value ("ARV") of grand prize: \$350. Grand Prize winner will be announced after the conclusion of the Chicago Blackhawks 2016-17 season. Minimum total ARV of all prizes: \$2,550.

Gift certificates subject to terms and conditions thereon. Winner is solely responsible for any applicable federal, state and local taxes in connection with winner's prize. Prize substitutions are not allowed, and the prize is not transferable. Only Sponsor may elect, at its discretion, to substitute a prize of greater or equal value due to lack of availability for any reason. 7) Other Conditions: Winner may be required to sign and return an Affidavit of Eligibility and Release, without revision or deletion, as well as any required tax documents and (in the case of Grand Prize winner) any release provided by the Blackhawks and, if so, it must be returned to Sponsor within seven days of the date Sponsor sends it to winner. Guest of Grand Prize winner (and parent or legal guardian of guest who is a minor) may be required to sign and return Release prior to attending game with Grand Prize winner. Winner may be required to provide proof of legal name, address, zip code, telephone number and social security number to receive prize (for example, in the form of a government-issued driver's license or identification card).

By entering this Sweepstakes, each entrant agrees to release, waive and hold harmless Sponsor, Nuveen, Pequod's Pizza, the Chicago Blackhawks, the National Hockey League and its member teams and their respective affiliates, subsidiaries, parent corporations and advertising and promotional agencies, and all of their officers, directors, shareholders, employees and agents (collectively, "Released Parties") from any and all injuries, claims damages, losses, costs, or expenses of any kind (including without limitation attorney's fees) resulting from submitting an entry or otherwise participating in any aspect of the Sweepstakes; the receipt, ownership or use of any prize awarded; preparing for, participating in or traveling to and/or from any prize-related activity, or; any printing, typographical or other error in these Official Rules or the announcement of offering of any prize.

Some jurisdictions do not allow for limitations on the ability to pursue class action remedies, or certain kinds of damages, and so these limitations may not apply to you. If a dispute arises regarding compliance with these Official Rules, Sponsor may consider, in its sole discretion, data reasonably available to Sponsor through information technology systems in Sponsor's control, but Sponsor will not be obligated to consider any data or other information collected from any other source. Sponsor assumes no liability for (a) any incorrect or inaccurate entry information; or (b) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Sweepstakes.

8) Internet: Sponsor reserves the right to cancel, modify or terminate the Sweepstakes if fraud, misconduct or technical failures destroy or threaten the integrity of the Sweepstakes, in the opinion of the Sponsor, or if a computer virus, bug, or other technical problem corrupts the administration, security, or proper conduct of the Sweepstakes as determined by Sponsor, in its sole discretion. If the Sponsor cancels, modifies, or terminates the Sweepstakes, Sponsor will post notice of its action on the Sweepstakes page and will pick the winner of the remaining first prizes in a random drawing from among eligible, non-suspect, non-winning entries received as of the Sweepstakes termination and will pick the Grand Prize winner as set forth above.
