

**The “ 2018-19 Breakfast with a Blackhawk presented by MB Financial Bank” Sweepstakes
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

The “2018-19 Breakfast with a Blackhawk presented by MB Financial Bank Sweepstakes” (“Sweepstakes”) begins at 12:01 am CT on Monday, September 24, 2018 and ends at 11:59 p.m. CT on Sunday, March 31, 2019 (“Sweepstakes Period”). This Sweepstakes will be subject to these Official Rules, and by entering, each entrant agrees to abide and be bound by these Official Rules and the decisions of the judges and Sponsor.

1) Eligibility: This Sweepstakes is open to legal U.S. residents of Illinois, Indiana, Wisconsin, Michigan, and Iowa (the “Sweepstakes Area”) who are 18 years and older as of the first day of the Sweepstakes Period. Employees, officers and directors (and their immediate household or family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) of WGN Radio (“Sponsor”) or MB Financial Bank, N.A. (“MB”), Chicago Blackhawks, the National Hockey League and its member teams, and their parent companies, affiliates, and subsidiaries, are not eligible to participate or win. Employees of other media companies including all radio, television, and cable stations, and members of the immediate family of any such persons are not eligible to participate or win. A potential winner may be requested to provide proof that all eligibility requirements are met. Void where prohibited and outside the Sweepstakes Area.

2) How to Enter: Complete the official entry form at www.wgnradio.com/contests during the Sweepstakes Period, accurately submitting your name, phone number, city, email address and a question for a Blackhawks player (the “Question”). Please note that your Question should not be directed toward a specific Blackhawk but should be a question that any member of the team could answer. If there is a dispute regarding the identity of an entrant, the holder of the email account will be deemed the person who submitted the entry.

Limit one entry per day per person. Limit one prize per person and per household. Entries containing technical or electronic reproductions or attached files are not eligible and will be rejected. Sponsor reserves the right in its sole discretion to disqualify any entry at any time that in Sponsor’s opinion does not comply with these Official Rules. Incomplete entries will be disqualified, and Sponsor is not responsible for entries that are lost, late, deleted, garbled, corrupted, misdelivered, or misdirected. Sponsor is not responsible for inability to transmit Internet entries. No mechanically reproduced entries will be accepted. Received entries (but not the Questions) become the property of Sponsor and will not be returned or acknowledged. Your information will be treated in accordance with Sponsor’s Privacy Policy, which is located at privacy.tribunemedia.com and which may be amended from time to time. By entering, entrants agree to be bound by and comply with these Official Rules.

3) Question Submission Requirements:

- Must be the original creation of the entrant;
- Must be in English;
- Must be no more than 25 words;
- Must not contain material that is inappropriate, indecent, lewd, pornographic, obscene, hateful, tortious, defamatory, slanderous or libelous; and
- Must not contain material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, religion, nationality, disability, sexual orientation or age.

By entering, each entrant represents and warrants that the submitted Question is in compliance with all of the foregoing requirements. By entering, each entrant understands and agrees that the Question may be read on air on WGN Radio and posted on the WGN Radio website, and the Question must be appropriate

for broadcast on a general-interest radio station and display on the station website. By entering, each entrant grants to the Tribune Broadcasting Company, LLC, its affiliates and entities, including Sponsor, and its affiliated Web sites and broadcast stations a world-wide, royalty-free, perpetual, irrevocable, non-exclusive right and fully sub-licensable license to use, copy, reproduce, distribute, publish, publicly perform, publicly display, modify, adapt, translate, archive, store, and create derivative works from his/her Question in any form, format, or medium, of any kind now known or later developed, without prior notice, approval or compensation. Nominators further grant rights in their Question as set forth in the Terms of Service on the Contest Website. Nominators otherwise will retain all rights to their respective Questions. Entrant agrees that the Question is subject to and in compliance with the Terms of Service on the WGN Radio website. Entrant represents and warrants that Sponsor's use of the Questions as provided for herein will not violate the rights of any third party. Entrants otherwise will retain all rights to their respective Questions. Each entrant agrees to indemnify, defend and hold Sponsor harmless against any and all liabilities, losses, damages, claims, debts, investigations, fines, penalties, costs, expenses and settlements (including attorneys' fees and costs of litigation, settlement, judgment, interest and penalties) arising out of or related to a breach of any of the foregoing representations and warranties. Sponsor reserves the right to reject any entry at any time that, in its sole and absolute discretion, is determined not to meet the above specifications.

4) Winner Selection and Notification: Every week during the Breakfast with a Blackhawk presented by MB Financial Bank segment on the Steve Cochran Show (the "Segment") (Segment time and day may change from week to week based upon scheduling and availability), Steve Cochran (or whoever is sitting in for Steve Cochran if he is not on the show that day) will read a listener Question randomly selected from all eligible, non-winning entries received prior to each Segment. Odds of winning depend on the number of eligible entries received for each drawing. Please note that the quality of the Question will not play a role in the determination of the winner, except that Questions deemed unsuitable for broadcast will not be eligible. Sponsor will determine suitability for broadcast in its sole discretion. Non-winning Questions carry over from Segment to Segment. Sponsor will make all decisions in any and all issues related to this Sweepstakes, and its decisions will be final and binding in all respects. Sponsor will attempt to notify the potential winner by email and/or telephone. A potential winner will be disqualified and an alternate potential winner may be selected by random drawing from among all remaining eligible entries for that drawing if (a) an entrant's Question is deemed unsuitable for broadcast, (b) a potential winner does not fulfill the eligibility requirements; (c) a potential winner does not adhere to the Official Rules; (d) a potential winner has already previously won a prize in the Sweepstakes; (e) a potential winner fails to provide required identification or sign and return required documents by the deadline established by Sponsor; and/or (f) if the prize notification is returned as undeliverable, refused, or declined, or if no response is received by Sponsor within 48 hours after notification is attempted. If the winner meets all potential winner eligibility requirements and accepts the prize and becomes unavailable to redeem the prize for any reason, Sponsor will not select a new winner and the prize will remain unused.

5) Prizes: There are 26 prizes—one prize per Segment during the Sweepstakes Period (total of 26 weeks). The winner will receive a hockey puck autographed by a Chicago Blackhawks player. Approximate retail value of signed puck between \$50 and \$130. The identity of the player signing the hockey puck sent to each winner is at the discretion of the Sponsor and may be different from the player interviewed on the Segment.

Each winner is solely responsible for any applicable federal, state and local taxes in connection with winner's prize. Prize substitutions are not allowed, and the prize is not transferable. Only Sponsor may elect, at its discretion, to substitute a prize of greater or equal value due to lack of availability for any reason. All properly claimed prizes will be awarded, but in no event will Sponsor award more prizes than are provided for in these Official Rules. If, for whatever reason, there are more than 26 Segments during the Sweepstakes Period or if a Segment is re-broadcast during the Sweepstakes Period, only 26 prizes will be awarded.

6) Other Conditions: Winner may be required to sign and return an Affidavit of Eligibility and Release, without revision or deletion and to provide required identification, and, if so, it must be returned to Sponsor within one week of the date Sponsor sends it to winner.

By entering this Sweepstakes, each entrant agrees to release, waive and hold harmless Sponsor, MB, Chicago Blackhawks, the National Hockey League and its member teams, and their respective affiliates, subsidiaries, parent corporations and advertising and promotional agencies, and all of their officers, directors, shareholders, employees and agents (collectively, "Released Parties") from any and all injuries, claims, damages, losses, costs, or expenses of any kind (including without limitation attorney's fees) resulting from accessing the Sweepstakes website; submitting an entry or otherwise participating in any aspect of the Sweepstakes; the receipt, ownership or use of any prize awarded; preparing for, participating in or traveling to and/or from any prize-related activity; or any printing, typographical or other error in these Official Rules or the announcement of offering of any prize.

By accepting the prize, the winner agrees to allow Sponsor and MB and their agents and licensees to use his/her name, voice, photograph, likeness and any information provided on the entry form, in any medium of communication, including advertising, promotional or other purposes, without additional compensation.

Neither the failure of Sponsor to insist upon or enforce strict performance of any provision of these Official Rules nor the failure, delay or omission by Sponsor in exercising any right with respect to any term of these Official Rules, will be construed as a waiver or relinquishment to any extent of Sponsor's right to assert or rely upon any such provision or right in that or any other instance. If there is a conflict between provisions of any materials describing this Sweepstakes or any statement made by Sponsor or MB representative and these Official Rules, these Official Rules will control.

7) Fraud/Tampering: Sponsor reserves the right to prohibit any entrant from participating in the Sweepstakes if, at its sole discretion, Sponsor finds such entrant to be tampering with the entry process or the operation of the Sweepstakes, or if such entrant shows a disregard for, or attempts to circumvent, these Official Rules, or acts: (a) in a manner the Sponsor determines to be not fair or equitable; (b) in an annoying, threatening, or harassing manner; or (c) in any other disruptive manner. If a dispute arises regarding compliance with these Official Rules, Sponsor may consider, in its sole discretion, data reasonably available to Sponsor through information technology systems in Sponsor's control, but Sponsor will not be obligated to consider any data or other information collected from any other source. Sponsor assumes no liability for (a) any incorrect or inaccurate entry information, or for any faulty, failed, garbled or jumbled electronic data transmissions; (b) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Sweepstakes; or (c) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, computers or providers utilized in any aspect of the operation of the Sweepstakes.

Should any portion of the Sweepstakes be compromised by virus, worms, bugs, non-authorized human intervention or other causes that corrupt or impair the administration, security, fairness or proper play, or submission of entries, Sponsor reserves the right at its sole discretion to suspend or terminate the Sweepstakes and select the winners for the remaining prizes from all eligible, non-suspect, non-winning entries received prior to action taken or as otherwise deemed fair and appropriate. The Released Parties (a) make no warranty, guaranty or representation of any kind concerning the prizes and (b) disclaim any implied warranty.

8) In Case of Dispute: By entering the Sweepstakes, entrants agree that: (a) any and all disputes, claims, and causes of action arising out of or connected with the Sweepstakes, or prize awarded, will be resolved individually, without resort to any form of class action; (b) any and all claims, judgments and awards will be limited to actual out-of-pocket costs incurred, including costs associated with entering the Sweepstakes but in no event attorneys' fees; and (c) under no circumstances will any entrant be permitted to obtain any award for, and entrant hereby waives all rights to claim punitive, incidental or consequential damages and any and all rights to have damages multiplied or otherwise increased and any other damages, other than for actual out-of-pocket expenses. Some jurisdictions do not allow for limitations on the ability to pursue class action remedies, or certain kinds of damages, and so these limitations may not apply to you. This Sweepstakes will be governed and enforced pursuant to Illinois law,

excluding choice of law provisions. All suits or claims brought in connection with this Sweepstakes must be brought in a state or federal court in Chicago, Illinois.
