

**“Ask Troy Murray 2018-19” Sweepstakes
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1) Eligibility: The “Ask Troy Murray 2018-19” Sweepstakes (the “Sweepstakes”) is open to legal U.S. residents of Illinois, Northwest Indiana (Jasper, Lake, LaPorte, Newton and Porter counties) and Southwest Wisconsin (Kenosha, Milwaukee, Racine, Walworth and Waukesha counties) who are 18 years old and older as of October 24, 2018. Employees (and their immediate household or family members) of WGN Radio (“Sponsor”), PERL Mortgage, Inc., Team Hochberg, Chicago Blackhawks and the National Hockey League and their member teams and their parent companies, affiliates, subsidiaries, advertising agencies, prize providers, promotion and delivery contractors and/or public relations companies associated with this Sweepstakes, are not eligible to participate. Employees of participating clients and their advertising agencies or of other media companies including all radio or television stations and members of the immediate family of any such persons are not eligible to participate and win. Entrants who have won a prize valued under \$600 from Sponsor within the last 60 days (counted from the date the entry was received), or have won a prize worth \$600 or more from Sponsor within the past two years, are ineligible to play or receive a prize in this Sweepstakes. For purposes of this Sweepstakes, an immediate family member is a spouse, parent, child or sibling. This Sweepstakes is void where prohibited and outside the Sweepstakes area above.

2) How to Enter: Sweepstakes starts at 5:00 pm CT on Wednesday, October 24, 2018 and ends at 11:59 pm CT on Sunday, March 31, 2019 (the “Sweepstakes Entry Period”).

Enter during the Sweepstakes Entry Period at www.wgnradio.com/contests. Entrants must accurately complete all required fields in the entry form, including entrant’s name, birthdate, telephone number, email address, city, county and state of residence, and a question for Troy Murray about his career, the Blackhawks, hockey, or the NHL (the “Question”). Entrants must use their own name and current state of residency.

3) Conditions of Entry: Limit one entry per person and per email address per day. Entrants may not ask the same Question twice. Entries in excess of these limits may be disqualified if discovered by Sponsor. No mechanically reproduced entries will be accepted. Entries containing technical or electronic reproductions or attached files are not eligible and will be rejected. If any dispute arises as to identity of any entrant, the entrant will be considered the individual to whom the entry’s email address is assigned, as shown on the email service provider’s records. Only entries to the designated email address will be eligible. Sponsor reserves the right in its sole discretion to disqualify any entry at any time that in Sponsor’s opinion does not comply with these Official Rules. Sponsor is not responsible for lost, incomplete, damaged, illegible, late, or misdirected entries, or for errors in mechanical transmission, technical difficulties or inability to transmit Internet entries. Participation in the Sweepstakes is subject to these Official Rules. Received entries (but not the Questions) become the property of Sponsor and will not be returned or acknowledged. Your information will be treated in accordance with Sponsor’s Privacy Policy, which is located at privacy.tribunemedia.com and which may be amended from time to time. By entering, entrants agree to be bound by and comply with these Official Rules.

4) Question Submission Requirements:

- Must be about Troy Murray’s career, the Blackhawks, hockey, or the NHL;
- Must be the original creation of the entrant;
- Must be in English;
- Must be no more than 25 words;
- Must be in compliance with the Terms of Service on the Sweepstakes website;
- Must not contain material that is inappropriate, indecent, lewd, pornographic, obscene, hateful, tortious, defamatory, slanderous or libelous; and

- Must not contain material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, religion, nationality, disability, sexual orientation or age.

By entering, each entrant represents and warrants that the submitted Question is in compliance with all of the foregoing requirements. By entering, each entrant understands and agrees that the Question may be read on air on WGN Radio and posted on the WGN Radio website, and the Question must be appropriate for broadcast on a general-interest radio station and display on the station website. Entrant represents and warrants that Sponsor's use of the Questions as provided for herein will not violate the rights of any third party. By entering, entrant grants to the Tribune Broadcasting Company, LLC, and its affiliates and entities, including WGN, and its affiliated Web sites and broadcast stations a world-wide, royalty-free, perpetual, irrevocable, non-exclusive right and fully sub-licensable license to use, copy, reproduce, distribute, publish, publicly perform, publicly display, modify, adapt, translate, archive, store, and create derivative works from his/her Question in any form, format, or medium, of any kind now known or later developed, without prior notice, approval or compensation. Each entrant further grant rights in their Question as set forth in the Terms of Service on the Contest Website. Entrants otherwise will retain all rights to their respective Questions. Each entrant agrees to indemnify, defend and hold Sponsor harmless against any and all liabilities, losses, damages, claims, debts, investigations, fines, penalties, costs, expenses and settlements (including attorneys' fees and costs of litigation, settlement, judgment, interest and penalties) arising out of or related to a breach of any of the foregoing representations and warranties. Sponsor reserves the right to reject any entry at any time that, in its sole and absolute discretion, is determined not to meet the above specifications.

5) Question Selection and Entrant Notification: Sponsor will select an entrant's Question in random drawings from among eligible entries to take place on or about each Monday during the Sweepstakes Entry Period. An entrant whose Question is selected will be deemed a "Selected Entrant." Please note, the quality of the Question will not play a role in the determination of the Selected Entrant. The first drawing will be held on Monday, October 29, 2018 for the segments that will take place on Thursday, November 1, 2018 and Saturday, November 3, 2018. Over the holidays, drawings will be held on Friday, December 21 and 28 instead of Monday, December 24 and 31. To be eligible for a drawing, an entry must be received by noon CT on the drawing date. Each drawing date, Sponsor will select Questions for any games held from the Tuesday after the drawing date to the following Monday. Sponsor will select Questions for Blackhawks regular season games. All Questions and entrants are subject to verification and compliance with these Official Rules. Non-winning entries will carry over from one drawing to the next. Sponsor will attempt to notify each Selected Entrant by email or telephone on or shortly after each drawing. Selected Entrant will be disqualified and an alternate Selected Entrant may be selected by random drawing from among all remaining eligible entries for that drawing (time permitting and at the sole discretion of Sponsor) if: (a) Selected Entrant's Question is determined not to be appropriate for an on-air reading; (b) Selected Entrant does not fulfill the eligibility requirements; (c) Selected Entrant does not adhere to the Official Rules; and/or (d) Selected Entrant notification is returned as undeliverable, refused or declined. Odds of being chosen as a Selected Entrant depend on the number of eligible entries received for each drawing and the number of Selected Entrants chosen in each drawing.

6) Selection of Grand Prize Winner: Sponsor will conduct a random drawing on or about Tuesday, April 2, 2019 among all Selected Entrants whose Questions are read on the air and answered by Troy Murray (minimum of 69 Selected Entrants) to receive one Grand Prize. The odds of being selected as the Grand Prize winner are up to one in 69. Potential winner will be disqualified and an alternate entrant may be selected by random drawing from among all remaining eligible Selected Entrants (time permitting and at the sole discretion of Sponsor) if: (a) potential winner does not respond within 24 hours of initial notification attempt; (b) potential winner does not fulfill the eligibility requirements; (c) potential winner does not adhere to the Official Rules; (d) potential winner does not provide required identification or sign and return required documents by deadline set by Sponsor; and/or (e) Selected Entrant notification is returned as undeliverable, refused or declined.

7) Grand Prize and Prize Restrictions: One Grand Prize: The Grand Prize winner will receive two tickets to the Team Hochberg Center Ice Suite for the Chicago Blackhawks vs. Dallas Stars at the United

Center on Friday, April 5, 2019 at 7:30 pm CT. Approximate retail value of grand prize: \$500. There is no prize for being a Selected Entrant.

Grand Prize winner is solely responsible for any applicable federal, state and local taxes and any other expenses not specifically provided for herein in connection with winner's prize. Prize substitutions are not allowed, and the prize is not transferable. Only Sponsor may elect, at its discretion, to substitute a prize of greater or equal value due to lack of availability for any reason. Winner is responsible for all expenses not specifically set forth herein.

8) Other Conditions: Winner may be required to sign and return an Affidavit of Eligibility and Release, without revision or deletion, as well as any required tax documents and any release provided by the Blackhawks and, if so, it must be returned to Sponsor within seven days of the date Sponsor sends it to winner. Guest of Grand Prize winner (and parent or legal guardian of guest who is a minor) may be required to sign and return Release prior to attending game with Grand Prize winner. Winner may be required to provide proof of legal name, address, zip code, telephone number and social security number to receive prize (for example, in the form of a government-issued driver's license or identification card).

By entering this Sweepstakes, each entrant agrees to release, waive and hold harmless Sponsor, PERL Mortgage, Team Hochberg, the Chicago Blackhawks, the National Hockey League and its member teams and their respective affiliates, subsidiaries, parent corporations and advertising and promotional agencies, and all of their officers, directors, shareholders, employees and agents (collectively, "Released Parties") from any and all injuries, claims damages, losses, costs, or expenses of any kind (including without limitation attorney's fees) resulting from submitting an entry or otherwise participating in any aspect of the Sweepstakes; the receipt, ownership or use of any prize awarded; preparing for, participating in or traveling to and/or from any prize-related activity, or; any printing, typographical or other error in these Official Rules or the announcement of offering of status as selected Entrant or prize.

Neither the failure of Sponsor to insist upon or enforce strict performance of any provision of these Official Rules nor the failure, delay or omission by Sponsor in exercising any right with respect to any term of these Official Rules, will be construed as a waiver or relinquishment to any extent of Sponsor's right to assert or rely upon any such provision or right in that or any other instance. As a condition of entering, entrants agree: (a) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental, consequential, or any other damages, other than for actual out-of-pocket expenses; (b) all causes of action arising out of or related to this Sweepstakes, or prize awarded, will be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Cook County, Illinois, to which participant submits to personal jurisdiction; and (c) any and all claims, judgments, and award will be limited to actual out-of-pocket costs incurred, excluding attorneys' fees and court costs. Some jurisdictions do not allow for limitations on the ability to pursue class action remedies, or certain kinds of damages, and so these limitations may not apply to you. This Sweepstakes will be governed and enforced pursuant to Illinois law, excluding choice of law provisions.

Sponsor reserves the right to prohibit any entrant from participating in the Sweepstakes if, at its sodiscretion, Sponsor finds such entrant to be tampering with the entry process or the operation of the Sweepstakes, or if such entrant shows a disregard for, or attempts to circumvent, these Official Rules, or acts: (a) in a manner the Sponsor determines to be not fair or equitable; (b) with an intent to annoy, threaten or harass any other entrant or Sponsor; or (c) in any other disruptive manner. If a dispute arises regarding compliance with these Official Rules, Sponsor may consider, in its sole discretion, data reasonably available to Sponsor through information technology systems in Sponsor's control, but Sponsor will not be obligated to consider any data or other information collected from any other source.

Sponsor assumes no liability for (a) any incorrect or inaccurate entry information; or (b) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Sweepstakes.

9) Internet: Sponsor reserves the right to cancel, modify or terminate the Sweepstakes if fraud, misconduct or technical failures destroy or threaten the integrity of the Sweepstakes, in the opinion of the Sponsor, or if a computer virus, bug, or other technical problem corrupts the administration, security, or proper conduct of the Sweepstakes as determined by Sponsor, in its sole discretion. If the Sponsor cancels, modifies, or terminates the Sweepstakes, Sponsor will post notice of its action on the Sweepstakes page and will pick the remaining Selected Entrants in a random drawing from among eligible, non-suspect, non-winning entries received as of the Sweepstakes termination and will pick the Grand Prize winner as set forth above.
